Ordinance No. 2020 Passed , 20 20

AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO APPYLY FOR AND ACCEPT FY 2020 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) CRITICAL INFRASTRUCTURE FUNDS THROUGH THE PICKAWAY COUNTY BOARD OF COMMISSIONERS AND THE STATE OF OHIO AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, PICKAWAY COUNTY, AND STATE OF OHIO AS FOLLOWS:

SECTION I. That the Director of Public Service is authorized to make application for the maximum amount of FY 2020 CDBG Critical Infrastructure Funds through the Pickaway County Board of Commissioners and the State of Ohio and to execute any and all documents necessary for applying for and accepting said funds on behalf of the City of Circleville and to execute any and all documents necessary to receive the same on behalf of the City of Circleville.

SECTION II. That the Director of Public Service is authorized to work with the Pickaway County Commissioner’s Office and their consultant, as an acquired city, related to the administration of any contracts and documentation necessary to the execution of the designated project.

SECTION III. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health or safety of the citizens of the City of Circleville; the emergency being to avoid unnecessary delay in the application process; wherefore, this Ordinance shall be in full force and effective immediately upon the passage.

AN ORDINANCE AUTHORIZING AND DIRECTING THE DIRECTOR OF PUBLIC SERVICE TO SUBMIT AN APPLICATION AND ENTER INTO AN AGREEMENT WITH THE STATE OF OHIO FOR STATE CAPITAL IMPROVEMENT PROGRAM (SCIP) AND LOCAL TRANSPORTATION IMPROVEMENT PROGRAM (LTIP) FUNDS, FOR ROAD AND UTILITY IMPROVEMENTS FOR CEDAR HEIGHTS ROAD AND DECLARING AN EMERGENCY.

WHEREAS, District 17 Integrating Committee is authorized to provide financial assistance to units of general local government for undertaking and carrying out local improvement activities; and

WHEREAS, the road and utility improvements for Cedar Heights Road, fit the criteria necessary for SCIP and LTIP Funding; and

WHEREAS, the members of the Council of the City of Circleville have general knowledge of the proposed use of such funds and are cognizant of the conditions that are imposed in the undertaking and carrying out of these activities with state financial assistance under the State Capital Improvements Program, including those prohibiting discrimination because of race, color, creed, sex, or national origin; NOW, THEREFORE

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, STATE OF OHIO:

SECTION I. That the Director of Public Service of the City of Circleville is hereby authorized to file an application for funds from the District 17 Integrating Committee, for the road and utility improvements for Cedar Heights Road, which fit the criteria for funding, and provide all information and assurances as may be necessary under the State Capital Improvements Program and Local Transportation Improvement Program.

SECTION II. That the Director of Public Service of the City of Circleville is hereby authorized to enter into an agreement with the State of Ohio for financial assistance under the State Capital Improvement Program and Local Transportation Improvement Program.

SECTION III. That the Director of Public Service of the City of Circleville is hereby authorized to execute and carry out all programs, bids, contracts and all other activities set forth in the agreement.

SECTION IV. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health or safety of the citizens of the City of Circleville; the emergency being to avoid unnecessary delay in the application process; wherefore, this Ordinance shall be in full force and effective immediately upon the passage.
