**AN ORDINANCE AMENDING THE ANNUAL APPROPRIATION
ORDINANCE IN THE GENERAL FUND 101
OF THE CITY OF CIRCLEVILLE**

Whereas, it is necessary to amend the appropriation ordinance known as 03-05-2020; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CIRCLEVILLE, STATE OF OHIO:

SECTION I: That the annual appropriation ordinance be amended in the **General Fund 101** by **reducing** a department function by the following amount:


SECTION V: That this Ordinance shall take effect and be in force from and after the earliest period permitted by law.


